1. Introduction

The Annual Information Form is hereby amended (a) in connection with an amendment to the fund facts of the Balanced Funds and (b) to reflect the withdrawal of a portfolio sub-manager and the selection of a new portfolio sub-manager with respect to a portion of the Dividend Fund's assets.

2. Amendments to the Annual Information Form

On August 27, 2020, the Fund Manager announced the withdrawal of Lincluden Investment Management Limited ("Lincluden") and the selection of Desjardins Global Asset Management Inc. ("DGAM") as sub-manager of a portion of the Dividend Fund's assets. Mr. Tommy Nguyen is the individual principally responsible for the investment advisory services provided by DGAM to the Dividend Fund.

The Dividend Fund's assets are managed in part by DGAM, Manulife Asset Management Limited and Beutel, Goodman & Company Ltd, as portfolio sub-managers, whereas the Fund Manager continues to ensure internally the management of the remainder of the Dividend Fund's assets.

The Annual Information Form is amended as follows:

The information with respect to the Dividend Fund that is provided in the table starting on page 3 of the Annual Information Form under the section entitled "Name and Formation of the Funds" is hereby deleted and replaced with the following:
