What does the fund invest in?

The fund aims to achieve a long-term global return through an appropriate stock selection and by taking advantage of interest rate and currency rate shifts on world markets. The fund invests primarily (either directly or indirectly through investments which provide exposure to such securities) in debt instruments of foreign issuers (including debt instruments issued by various levels of government, including municipal governments, and by public and quasi-public entities) that may be denominated in other currencies than the Canadian dollar and have different maturity dates. The issuers of securities may be established worldwide, including Canada and emerging countries. The fund may invest up to 100% of its net assets in foreign securities and up to 40% in emerging markets securities.

The charts below provide a snapshot of the fund's holdings on April 30, 2025. These holdings will change over time.

How risky is it?

The value of the fund can go down as well as up. You could lose money.

One way to gauge risk is to look at how much a fund's returns change over time. This is called "volatility".

In general, funds with higher volatility will have returns that change more over time. They typically have a greater chance of losing money and may have a greater chance of higher returns. Funds with lower volatility tend to have returns that change less over time. They typically have lower returns and may have a lower chance of losing money.

Risk rating

Professionals' Financial - Mutual Funds Inc. has rated this fund's volatility as **low to medium**. This rating is based on how much the fund's returns have changed from year to year. It doesn't tell you how volatile the fund will be in the future. The rating can change over time. A fund with a low risk rating can still lose money.

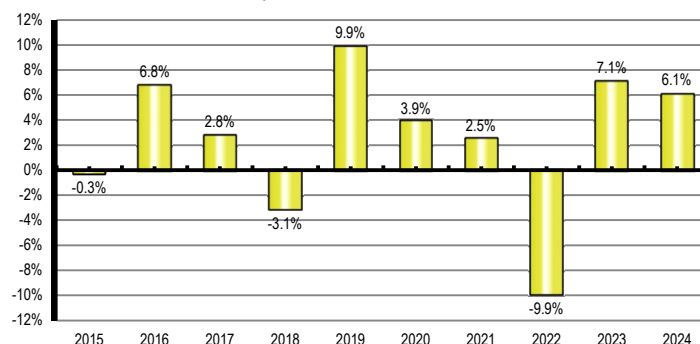
Like most mutual funds, this fund doesn't have any guarantees. You may not get back the amount of money you invest.

How has the fund performed?

This section tells you how the fund's Series A units have performed over the past 10 years. Returns are after expenses have been deducted. These expenses reduce the fund's returns.

Year-by-year returns

This chart shows how Series A units of the fund performed in each of the past 10 years. The fund dropped in value in 3 of the 10 years. The range of returns and change from year to year can help you assess how risky the fund has been in the past. It does not tell you how the fund will perform in the future.

Best and worst 3-month returns

This table shows the best and worst returns for Series A units of the fund in a 3-month period over the past 10 years. The best and worst 3-month returns could be higher or lower in the future. Consider how much of a loss you could afford to take in a short period of time.

Average return

A person who invested \$1,000 in Series A units of the fund 10 years ago, now has \$1,231. This works out to an annual compound return of 2.1%.

How much does it cost?

The following tables show the fees and expenses you could pay to buy, own and sell Series A units of the fund. The fees and expenses — including any commissions — can vary among series of a fund and among funds. Higher commissions can influence representatives to recommend one investment over another. Ask about other funds and investments that may be suitable for you at a lower cost.

1. Sales charges

There are no sales charges on this fund.

2. Fund expenses

You don't pay these expenses directly. They affect you because they reduce the fund's returns. As of December 31, 2024, the fund's expenses were 1.69% of its value. This equals \$16.90 for every \$1,000 invested.

Annual rate (as a % of the fund's value)

Management expense ratio (MER)

This is the total of the fund's management fee (which includes the trailing commission) and operating expenses. 1.65%

Trading expense ratio (TER)

These are the fund's trading costs. 0.04%

Fund expenses 1.69%

Who is this fund for?

Investors who:

- ♦ Seek capital preservation and steady income generation;
- ♦ Have a long-term investment horizon;
- ♦ Have a low to medium risk tolerance.

A word about tax

In general, you'll have to pay income tax on any money you make on a fund. How much you pay depends on the tax laws where you live and whether or not you hold the fund in a registered plan, such as a Registered Retirement Savings Plan or a Tax-Free Savings Account.

Keep in mind that if you hold your fund in a non-registered account, fund distributions are included in your taxable income, whether you get them in cash or have them reinvested.

What if I change my mind?

Under securities law in some provinces and territories, you have the right to:

- ♦ withdraw from an agreement to buy mutual fund units within 2 business days after you receive a simplified prospectus, or Fund Facts document, or
- ♦ cancel your purchase within 48 hours after you receive confirmation of the purchase.

In some provinces and territories, you also have the right to cancel a purchase, or in some jurisdictions, claim damages, if the simplified prospectus, Fund Facts document or financial statements contain a misrepresentation. You must act within the time limit set by the securities law in your province or territory.
